Treasury report - M Morehead reported May show profit between 20-22k, still have \$4700 in sponsorship money coming in, Embassy Suite bill still needs to be paid. Currently have \$141,619.39 in checking; \$108,000.00 in DC fund; \$20,174.17 in Raymond James fund for a total of \$269,793.56. M Morehead stated we are \$10,326.00 ahead for 2019. Board made a motion that we move \$25,000.00 from checking and \$75,000.00 from the DC fund to Raymone James account. Motion by B Kraatz with 2nd from B Becht

Education report - C Greenwood updated that Lilo Fore clinic will open next week Wednesday June 19 at 8 a.m. Cost will be \$175.00 per entry plus \$7.00 credit card fee. Total \$182.00 per entry

Membership report - C Greenwood updated that we currently have 165 members plus 6 online netries for a total of 171

Show committee report - S Woerth reported May profit of \$22,000.00. Discussed having judges book their airfare 3-4 months out for better rate or KDA using tracvel agent to book airfare for them. KDA paying too much in airfare costs. Looking for ways to cut this expense. Board suggested bringing only 1 judge from far away and for the others using more local judges. No more EMT's beyond 1 hour after show hours ends. Discussed 1 day shows for 2020 - Sheila, Anne, and Carri will start to check out possible venues for this. We need to look at all options such as venues, costs, what other

weekends are available in July, etc. Also need to decide if want to use Rolex again in 2020. Susan Peacock will keep portal open until June 28 for the July show. For Auguast schooling show entries will open June 28 and close July 19. Looking for venue for November schooling show as Stoneplace is up for sale. Board decided to delete Stoneplace altogether. Dates will be either Saturday Nov 23rd or Sunday Nov 24th.
